We utilize a web-based EAS that complies with 21 CFR Part 11 standards. This system improves the efficiency of the adjudication workflow while maintaining a comprehensive audit trail of all activities.

Our system offers a standardized and secure online data repository, protected by firewalls and restricted access platforms to ensure data integrity, and many other advantages, including:

- ▶ Secure, 24/7 access, with customizable restrictions based on protocol, site, user, and role
- ▶ Direct data uploads from sites, featuring built-in anonymization and redaction tools
- ▶ Centralized electronic tracking and storage of all event data and adjudication results
- ▶ Real-time audit trails and reporting for complete transparency throughout the process
- ▶ Direct export of adjudication results for detailed analysis
